The type of information we collect

The MGateway Ltd web site does not use cookies. It does, however, use web browsers' permanent storage facilities (specifically a technology known as indexedDB) to ensure smooth operation of the web site by:

- Optimizing the user experience.
- Recording user preferences.

The MGateway Ltd web site follows a standard procedure for using log files. These files log visitors when they visit websites. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analysing trends, administering the site, tracking users' movement on the website, and gathering demographic information.
